Awards Classification & Evaluation Process

To ensure a fair, transparent and meaningful evaluation, all nominations will be assessed independently within their respective classifications. Organisations and individuals will be evaluated alongside peers of similar size, operating environment and organisational maturity, ensuring that achievements are recognised within the appropriate context.

The ESG PLUS Awards 2026 comprise the following classifications:

- **Corporate**
- **SMEs / Startups**
- **Individuals**
- **NGOs / Social Enterprises**

Each classification will be evaluated independently by the Awards Evaluation Committee based on the relevance, quality, impact, innovation and overall effectiveness of the submitted ESG initiatives and supporting documentation.

Within each award category, recipients may be recognised with one of the following distinctions:

- **Gold Award** – *Presented to nominees demonstrating exceptional leadership, outstanding impact, innovation and excellence within the category.*
- **Silver Award** – *Presented to nominees demonstrating a strong commitment and significant achievements, with measurable impact and best practices.*
- **Bronze Award** – *Presented to nominees demonstrating commendable ESG initiatives and meaningful contributions within their respective category.*

This classification-based approach ensures that corporates, SMEs, startups, individuals, NGOs and social enterprises are each assessed against organisations or peers of similar scale and operating context, providing every nominee with a fair and equitable opportunity for recognition.

4. The Entry Requirements & Eligibility

- In order to qualify as an applicant for any of the Awards listed, the company must meet the following requirement
- **DULY INCORPORATED IN ASIA** - All applicants must be duly incorporated and registered with the relevant governing bodies in their respective home countries within Asia. Companies must provide valid business registration documents as proof

of legal operation and compliance with local regulations. Eligibility is limited to organizations legally recognized in their jurisdictions.

- **DURATION OF INITIATIVES** - Entries can be for projects (or projects/initiatives attached to the nominated individual) that are on-going or completed between January 2024 - 30 May 2026)
- For Start Ups, SMEs and Companies who have just started their ESG initiatives and are active for less than a year, you may also submit your entries, these projects may not be judged but will be listed and acknowledged under a different category as a work-in-progress within our editorial coverage and / or other activities under ESG PLUS.
- **NO FINANCIAL / LEGAL ISSUES** - the organisation must not be registered bankrupt, and does not have any leage suite/ reputation that impair the image, business and / or process of the applying organization or the award programme.
- **PROOF OF INITIATIVES** - the organization must provide regulatory or acknowledgement documentation for presented initiatives (ie. government engagement and acknowledge letters, news clippings, media articles, other reporting documents etc.)

- **DURATION OF INITIATIVES** – Entries may be submitted for initiatives undertaken or completed between **January 2023 and 30 June 2026**.
- **NEW ORGANISATIONS** – Newly established NGOs and Social Enterprises with initiatives active for less than one year are encouraged to submit. While these entries may not be eligible for competitive judging, they may be recognised as **Emerging Impact Initiatives** through ESG PLUS editorial features or other programme activities.
- **GOOD STANDING** – The organisation must not be subject to legal proceedings, regulatory sanctions or reputational issues that could adversely affect the integrity of the Awards.
- **SUPPORTING EVIDENCE** – Organisations should provide relevant documentation to substantiate their initiatives, including programme reports, government acknowledgements, grant reports, impact assessments, beneficiary data, media coverage, partnership agreements, testimonials or other evidence demonstrating measurable outcomes.
